

WHAT IS A PATENT?

• Protects one's rights to their invention

- Utility patent
 - Apparatus
 - Method
- Design patent

WHAT DOES A PATENT PROTECT?

- Exclusive use rights for a limited period of time
- A method:
 - Technical process (e.g., chemical process or software)
 - Business process (very hard since the Supreme Court's Alice case)
- An apparatus:
 - Physical components, how they interconnect
 - Mechanical
 - Electrical
 - Software

WHAT IS A PROVISIONAL PATENT?

- A one year placeholder
- Cheaper than a nonprovisional patent
- Needs to cover all aspects of the invention
- Be careful not to reveal trade secrets
- Must be enabling
- By itself, provides no rights

WHAT IS A TRADE SECRET?

- Generally:
 - something that is kept secret;
 - economic benefit from its secrecy;
 - not known or readily ascertainable;
 - must implement efforts to maintain its secrecy.
- Most states have adopted the Uniform Trade Secrets Act (UTSA)
- Federal Defend Trade Secrets Act (DTSA)

WHAT DOES A TRADE SECRET PROTECT?

- Technology
- Business methods
- Customer lists
- Business plans
- Secret Formulas (Coca Cola, KFC recipe)
- Ideas
- Negative knowhow
- Lots of things! Basically, anything that has value.

Get signed NDAs from everyone

Mark documents "CONFIDENTIAL"

PATENT OR TRADE SECRET?

Characteristic	Patents	Trade secrets
Public or private?	Public	Private
Owner's legal action	Easier?	Harder?
Cost	High	Low
Protection from theft	Harder?	Easier?
Time	Limited	Unlimited
Ownership	Restricted	Unregulated

- File at least one patent
- File it early
- Use a patent attorney

- Offensive reasons



 Steam Engine (1769)






BOURCES OF U.S. PATENT LAW


- > Constitution (Art. I, § 8, Clause 8)
- To Promote the Progress of Science and useful Arts, by securing for limited Times to Authors and Inventors the exclusive Right to their respective Writings and Discoveries."
- > Federal Statutes Enacted by Congress
 - First Patent Act of 1790
 - New Patent Laws Enacted by Congress in 1793, 1836, 1870, 1952, and 2011





PATENTS AS INTELLECTUAL PROPERTY

- United States is First Country to Authorize Protection of Patents (and Copyrights) in Founding Charter of Government
- "Exclusive Right" = Property
- Key Driver of Economic and Technological Revolutions in Past 200 Years
 - > Industrial Revolution
 - > Pharmaceutical Revolution
 - Computer Revolution
 - Biotech Revolution
 - Mobile Revolution














RELATIONSHIP BETWEEN PATENT RIGHTS AND GOP





